Please note that License Condition 11 with regard to the authorized users' training, License Condition 13 (Subitems E and F) with regard to the sealed source leak tests, License Condition 15 with regard to the inventory records and License Condition 16 with regard to the shutter check have been revised. In addition, License Conditions 18 and 23 regarding the initial mounting of the gauges and modifications made to the gauges, respectively, have been added. The changes appear in **bold** fonts.
