The purpose of this letter is to provide schedule information for the response to Request for Additional Information (RAI) No. 118 (Reference 1).

PPL requires additional time to finalize the responses to RAI No. 118 Question 02.05.02-1, Question 09.01.03-1, and Question 13.03-52, as follows:

Question 02.05.02-1 addresses Vibratory Ground Motion as discussed in Sections 3.8.5 of the Final Safety Analysis Report (FSAR), submitted as Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA). The response to RAI 118 Question 02.05.02-1 will be provided on or before November 16, 2012.

Question 09.01.03-1 addresses the Spent Fuel Pool Cooling and Cleanup System Level Instrumentation as discussed in Section 9.1 of the Final Safety Analysis Report (FSAR), submitted as Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA). The response to RAI No. 118 Question 09.01.03-1 will be provided on or before December 14, 2012.


Question 13.03-52 addresses the Emergency Planning System submitted as Part 5 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA). PPL continues to evaluate the information required to respond to RAI No. 118 Question 13.03-52. A schedule for providing the final response will be provided on or before August 3, 2012.

The only regulatory commitments in this correspondence are to submit responses to the referenced RAI No. 118 Question 02.05.02-1, Question 09.01.03-1, and provide the schedule for response to Question 13.03-52 on or before the dates provided.
