ORDER

(Granting Motion for Extension of Time to File an Answer)

On August 2, 2012, pursuant to 10 C.F.R. § 2.323(a) and Section G.2 of the Initial

Scheduling Order in this case,<sup>1</sup> the Staff of the U.S. Nuclear Regulatory Commission (Staff) filed

a motion<sup>2</sup> requesting an extension of time to file its answer to a motion for summary disposition

of Contention 4, filed by FirstEnergy Nuclear Operating Company (FENOC) on July 26, 2012<sup>3</sup>

In support of its motion Staff states that FENOC's Summary Disposition Motion is based

on, among other things, a revised Severe Accident Mitigation Alternatives (SAMA) analysis,

submitted on July 16, 2012.<sup>4</sup> In addition, FENOC's Summary Disposition Motion is supported

by 48 attachments, which comprise over 3,300 pages and address a multitude of issues related

to Contention 4 concerning SAMAs.<sup>5</sup> Staff also notes that there is currently pending in this docket a series of motions which seek to supplement a contention dealing with shield building cracking.<sup>6</sup> The answers to these motions are due at about the same time as the answers to FENOC's Summary Disposition Motion.<sup>7</sup>

As required by 10 C.F.R. § 2.323(b), Staff contacted counsel for Intervenors and FENOC regarding this motion. Staff states that Intervenors consented to Staff filing the extension request and indicated that they wished to make the motion a joint motion, or alternatively, requested the consent/non-opposition of FENOC and the Staff to have the same answer date as the Staff.<sup>8</sup> Staff and FENOC do not oppose Intervenors' request to have the same answer date date as the Staff.<sup>9</sup>

For good cause shown, the unopposed Staff motion is GRANTED. The NRC Staff and Intervenors shall file their answers to FENOC's Summary Disposition Motion no later than September 14, 2012.

It is so ORDERED.
