NEI 11-08, *Guidance on Submitting Security Plan Changes*, Revision 0, dated August 2012, was developed to provide information for licensees to consider when submitting security plan changes to the NRC. The security plan consists of the Physical Security Plan (PSP), Training and Qualification Plan (T&Q) and the Safeguards Contingency Plan (SCP). This guidance is intended to assist the licensee in determining types of information to analyze when considering whether to submit a 10 CFR 50.90 or a 10 CFR 50.54(p) plan change, and also includes guidance for licensees specifically applying for Remotely Operated Weapons Systems (ROWS) technology.

NEI 11-08, Revision 0, has been completed through the combined efforts of the NRC, NEI, and key industry personnel, in order to address regulatory issues that have the potential to impact site security licensing documents. It has also been designed to specifically address and provide a template for licensees who intend to implement ROWS technology at their site(s).
