This letter is to clarify our petition for regulation dated April 18, 2012.

In the original letter I sent on April 18, 2012 I wrote that in the petition for regulation dated June 27, 2005 the Organization of Agreement States requested that the compatibility of 10 CFR 31.6 be revised from "C" to "B."

The correct statement should have been that the OAS requested that the compatibility be changed from "B" to "C."

It is ADDM who is requesting in our petition dated April 18, 2012 that the compatibility be changed back from "C" to "B."
