In accordance with 10 CFR 50.54, "Conditions of Licenses," paragraph (p)(2), this letter provides Revision 12, dated August 3, 2012, of the Watts Bar Nuclear Plant Physical Security Plan, Training and Qualification Plan, Safeguards Contingency Plan and Independent Spent Fuel Storage Installation Security Program. The Tennessee Valley Authority (TVA) has evaluated this change and does not consider the revision to decrease the overall effectiveness of the plan.

Enclosure 1 provides a summary of changes. Enclosure 2 provides a copy of the Watts Bar Nuclear Plant Physical Security Plan, Training and Qualification Plan, Safeguards Contingency Plan and Independent Spent Fuel Storage Installation Security Program, Revision 12.


