Gentlemen:

The purpose of this transmittal is to notify the US NRC that TEI Analytical services, Inc. is contemplating an asset sale of its business and principal assets to Rockwood Service Corporation, a Delaware corporation with headquarters in Greenwich, CT. Rockwood is the parent company and sole owner of Acuren Inspection, Inc. ("All") and Acuren Group, Inc. ("AGI"), and WIT Inspection, Inc. ("WIT"). Rockwood's subsidiaries are collectively one of North America's largest providers of industrial radiography services. All and WIT currently hold Industrial Radiography licenses.

We would ask the information contained be with held from public disclosure at this time as discussions are continuing. We would promptly notify the US NRC when these are completed.

1. Description of Transaction

The proposed transaction is an asset purchase of the TEI business and assets. The acquisition would be made by a newco subsidiary of Rockwood.

2. Changes of Personnel

All existing TEI personnel, including all management and supervisory personnel responsible for execution of TEI's radiation safety program would be retained with no change in job duties.

3. Changes of Location, Equipment or Procedures

TEI operations post-close would continue from existing facilities, using existing equipment and pursuant to existing procedures.

4. Surveillance Records

TEI's surveillance program is current and all required surveillance has been performed, documented and reviewed, including the results, if appropriate.

5. Decommissioning and Related Records Transfer

TEI Newco will be responsible for the maintenance of these records until the license is terminated. All required records will remain in possession of TEI with no change in records storage or handling processes.

6. Transferee's Commitment to Abide by the Transferor's Commitments

TEI Newco commits to abide by all constraints, license conditions, requirements, representations and commitments identified in and attributed to the existing license.


