This is in reference to your application dated February 7, 2012 and July 27, 2012 where you have requested to renew your NRC License. Please clarify and/or provide the following information:

1. In letter dated January 5, 2012 you request all correspondence be sent to a specific address, which coincides with the address currently on the license. However, in both applications dated February 7, 2012 and July 27, 2012 you state a different mailing address. Please confirm the mailing address. If it is in fact, 1400 29th Street, P.O. Box 5012, Great Falls, Montana, please explain why the address is different.
2. In application dated July 27, 2012, you have requested "Any byproduct material permitted by 10 CFR 35.300" and "Iodine-131". Please note, the use of Iodine-131 is permitted under the 10 CFR 35.300 modality. Therefore, they are not written on the license as two separate items. Please establish a maximum possession limit for the 35.300 modality taking into account the Iodine-131 usage. Currently, the limit on the license is 600 millicuries.
3. Please state if the only isotope you are using is Iodine-131 under 35.300 AND if you would like to be restricted to only that isotope.
4. Please state a maximum possession limit for the pre-packaged kits for the In vitro studies. It is listed on your license as "As needed", however for this particular modality we need a maximum possession limit.

Please respond to this email by Thursday, August 9, 2012.
