As per my phone conversation yesterday with your consultant, Adam Henry, additional information is needed to process your amendment request.

- Please provide the model and serial number of your Cesium 137 vial reference source if the activity exceeds the limits allowed by 10 CFR 35.65 (30 mCi).
- Please verify the survey meter you have purchased is consistent with the commitment made regarding radiation monitoring equipment in your license application submitted on November 12, 2009.
