Richard, Charlie, and Jason,

In answer to Richard's questions:

1. Yes, 220K was received by SNL after the November MLSR and is now spendable; 2. Yes, 33K went to PRC invoices and 18K went to direct labor and 3K went to travel; 3. I am in the process of evaluating all of the information streams from the peer review committee including the documentation comments that were resolved in February, 2010, the draft committee reports and unresolved issues, and, most recently, the committees comments on the uncertainty quantification. I had an extensive conversation with Jason and Charlie this morning regarding this issue and we have identified a path forward. So there is nothing for NRC staff to review right now but there will be a response to the peer review committee that I will put together in January that will need your review. 4. This was work that Nate did in response to requests from Jason and Charlie. Similar charges will appear in the December MLSR. 5. As of December 17, 2010, the total costs for the SOARCA project were \$6,910.9k. By my calculation that leaves approximately \$129k of the FY10 carryover unspent. With monthly project costs averaging \$106k per month since October, 2010 I believe the FY10 carryover will be spent by the end of February, 2011.

On another issue, Jason left me a voice mail regarding the November, 2010 MLSR which we just sent out. If I understand his message correctly he thought the uncertainty quantification effort costs (Task 9 and 10) were \$75k in November and he wanted a more detailed cost breakdown. I am a bit confused by his message since the uncertainty analysis costs for November were \$19.4k (\$0k Task 9, \$19.4k Task 10). Perhaps I don't understand Jason's question but that is the best response I have right now.
