Jennifer,

This email is a follow-up to your conversation with Sam Williamson, the Federal Coordinator for Meteorology, this morning concerning NRC inputs to the FY2011 Federal Plan for Meteorological Services and Supporting Research that we prepare for OMB on behalf of the Federal meteorological community. This plan lays out the agencies' activities, programs, and plans and includes budget information from the President's Budget for the fiscal year of the plan, as well as the actual appropriations for the preceding fiscal year. This annual plan is a requirement deriving from Public Law 87-843. Each of the agencies provides input to us which we use to prepare the plan -- we are finalizing the FY11 plan now and need the NRC inputs so we can send it up to OMB as soon as possible. We were unaware that Jocelyn had passed away and regrettably, this makes our request an urgent one at this point as we finish up the plan. Thank you for your help!

I have attached two files for your review and use.

1. The Word file is what we have prepared to describe NRC activities (based on the FY10 input) in the FY11 plan for both Section 2 (budget narratives) and Section 3 (agency programs).

- The Section 2 narrative and the tables (mentioned in item 2 below) are from 2009 NRC inputs (we did not receive an FY10 budget input). Please review and edit as necessary to accurately describe your agency budget for meteorological services and supporting research.

- If you look at previous years' plans, you will notice Section 3 has been organized by agency. This year we have arranged Section 3 by service category (such as basic services, agriculture, military, and emergency response/homeland security) and described agency activities within each service category to provide a cross-agency perspective for that area of services or supporting research. The NRC input has traditionally been quite short (a couple of pages) and this year we have integrated it into the Emergency Response and Homeland Security Services category. Please review and edit the attached Word file for us to incorporate in Section 3 of the plan.

2. The pdf file contains the budget tables so you can see the information we are seeking here. These are FY09 data since we do not have input from FY10 (perhaps the program funding was eliminated?).

I expect this is initially confusing and we're standing by to help answer your questions and wrap this up quickly. My contact information is listed below.

We are very sad to learn that Jocelyn Mitchell passed away -- she was always a great supporter and participant in a number of our coordinating groups and we will miss her very much. She was the NRC representative on our second highest group, the Interdepartmental Committee for Meteorological Services and Supporting Research (ICMSSR) and I will contact you separately to arrange for her replacement on ICMSSR and elsewhere.

Thank you for your help. I look forward to working with you.
