The purpose of this modification is to add an additional stop to the Loop B shuttle on Old Georgetown Road at the main construction entrance for the 3WFN building for the base period of this contract. The ceiling and obligated amount is therefore increased by \$6,245.00 (\$1,249.00 monthly for 5 months) from \$751,391.94 to \$757,636.94.
