Office of the Chief Human Capital Officer U.S. Nuclear Regulatory Commission Specific Acquisition Training Program

On July 31, 2012, as a result of a non-competitive 8(a) solicitation, a hybrid firm fixed-price/labor hour contract (NRC-HQ-12-C-38-0070) was awarded to Hickory Ground Solutions, LLC. of Heathsville, VA. The contractor will provide training services to U.S. Nuclear Regulatory Commission (NRC) Contracting Officer Representatives in order to satisfy NRC specific competencies associated with acquisitions. The period of performance is August 1, 2012, to July 31, 2013, with four 1-year optional periods. The cost is \$293,150, inclusive of all option periods.

Graphics Services – Office of the Chief Financial Officer Financial and Performance Reports

On August 3, 2012, as a result of a competitive U.S. General Services Administration Federal Supply Schedule solicitation, a firm fixed-price contract (NRC-HQ-12-F-09-0001) was awarded to Graphic Visions of Gaithersburg, MD. This contract will provide graphic services to produce the Office of the Chief Financial Officer's financial and performance reports. The period of performance is August 20, 2012, to August 19, 2013, with four 1-year optional periods. The total cost is \$244,960.49, inclusive of all options.

Access Authorization Fees; Correction; Correcting Amendments; 10 CFR Parts 11 and 25 (RIN 3150-AJ00; NRC-2011-0161)

On August 3, 2012, the NRC published in the *Federal Register* (77 FR 46257) a correcting amendment for the preamble, or statement of considerations, and codified text in a direct final rule that was published in the *Federal Register* on May 3, 2012 (77 FR 26149) and confirmed on June 22, 2012 (77 FR 37553). The direct final rule amended the NRC's access authorization fees charged to licensees for work performed under the Material Access Authorization Program and the Information Access Authority Program. This document is necessary to correct an e-mail address, a codification error, a misspelled abbreviation, and the authority citations. The correction is effective on August 3, 2012, and applicable to June 22, 2012, the date the original rule became effective.

Amendments to Adjudicatory Process Rules and Related Requirements; Final Rule; 10 CFR Parts 2, 12, 51, 54, and 61 (RIN 3150-AI43; NRC-2008-0415)

On August 3, 2012, the NRC published a final rule in the *Federal Register* (77 FR 46561) amending its adjudicatory rules of practice. This rule makes changes to the NRC's adjudicatory process that the NRC believes will promote fairness, efficiency, and openness in NRC adjudicatory proceedings. This rule also corrects errors and omissions that have been identified since the major revisions to the NRC's rules of practice in early 2004. This rule will be effective on September 4, 2012.
