SUBJECT: SUMMARY OF JULY 31, 2012, MEETING WITH NAC INTERNATIONAL
TO DISCUSS A REVISION REQUEST TO ADD NRU/NRX FUEL AS
AUTHORIZED CONTENTS IN THE MODEL NO. NAC-LWT
TRANSPORTATION PACKAGE (TAC NO. L24656)

Background

A meeting was held on July 31, 2012, in Rockville, Maryland, to discuss a revision request for the Model No. NAC-LWT transportation package. NAC International (NAC or the applicant) asked for the meeting to discuss a revision request to add National Research Universal/National Research Experimental (NRU/NRX) fuel as an authorized content in the NAC-LWT Certificate of Compliance (CoC) No. 9225. This request is a high priority for review to support the Department of Energy's Global Threat Reduction Program. Additionally, NAC discussed the need for an expedited review.

The meeting was noticed on June 26, 2012 (ML12178A648). The meeting attendance list is provided as Enclosure No. 1.

Discussion

The discussion generally followed the agenda (Enclosure No. 2). The primary reason for the meeting was to discuss a request for a revision request to CoC No. 9225 to authorize the content addition of NRU/NRX fuel.

The request is to ship the NRU/NRX reactor fuel from Canada to the U.S. under the Foreign Research Reactor fuel return program. The payload is undamaged and damaged uranium/aluminum fuel rod bundles. The NRU bundles consist of 12 fuel rods, and the NRX bundles consist of 7 fuel rods. Each bundle contains approximately 0.5 kg ²³⁵U.

NAC first provided a general overview of the revision request, followed by technical presentations, and a discussion of the schedule. The basket design and the fuel description were generally described. Each basket accommodates up to 18 NRU or NRX fuel bundles.

In the structural evaluation discussion, the design configuration was described. Additionally, the evaluation of the top and bottom end plates using a finite element analysis (FEA) model was discussed. Additionally, minimum safety factors were presented based on a 3D ANSYS model.

For the thermal evaluation discussion, NAC stated that the maximum total heat load in the package is 200 W. The current ANSYS model in the Safety Analysis Report (SAR) for the NAC-

NAC intends to submit the revision application in early September 2012. Another meeting to describe the application to the review team will be planned shortly thereafter to support an accelerated schedule request for issuing the revision by March 2013.
