Dear Mr. Dean:

Section V.F of the referenced NRC Confirmatory Order (CO) pertains to Entergy’s assessment of the Radiological Protection (RP) Departments at each of our nine nuclear power plant sites. Section V.F states: “Within 360 days of the date of the CO, Entergy will develop an assessment plan and conduct an assessment consistent with that plan of the RP Departments at the nine

Entergy commercial nuclear power plants. That assessment will review the rigor with which members of the RP Departments perform and document routine department activities. If those assessments identify performance or documentation issues, Entergy will enter those issues into its Corrective Action Programs. Prior to the conduct of the first assessment, Entergy will make the assessment plan available to the NRC for review.”

This letter is to inform you that Entergy has prepared an assessment plan and has established a proposed schedule for conducting the assessments at each site consistent with the deadline specified in the CO. The plan is available for review and the first assessment is currently scheduled to commence on July 16, 2012.
