SUBJECT: SUMMARY OF JULY 18, 2012, MEETING BETWEEN THE UNITED STATES NUCLEAR REGULATORY COMMISSION STAFF AND GENERAL ELECTRIC-HITACHI NUCLEAR ENERGY TO DISCUSS OUTSTANDING REQUESTS FOR ADDITIONAL INFORMATION RESPONSES RELATING TO STEAM DRYER AUDIT TO SUPPORT THE ECONOMIC SIMPLIFIED BOILING-WATER REACTOR DESIGN CERTIFICATION

On July 18, 2012, the U.S. Nuclear Regulatory Commission (NRC) staff held a conference call with General Electric-Hitachi Nuclear Energy (GEH) staff to discuss resolution of open items and outstanding requests for additional information (RAI) responses resulting from the steam dryer audit in support of the safety review of the GEH Economic Simplified Boiling-Water Reactor (ESBWR) Design Certification (DC).
