SUBJECT: SUMMARY OF AUGUST 8, 2012, PUBLIC MEETING TO
DISCUSS SEVERE ACCIDENT CODES AND MODELS FOR
RADIOLOGICAL RELEASE

On August 8, 2012, the U.S. Nuclear Regulatory Commission (NRC) held a Category 2 public meeting with the Electric Power Research Institute (EPRI), industry representatives and members of the public to discuss the results of industry's analysis and assessment of possible severe accidents in boiler water reactor Mark I and Mark II containments using various codes and models for radiological releases.

The meeting started with the NRC making a presentation (Agencywide Documents Access and Management System (ADAMS) Accession No. ML12229A293, discussing the role of uncertainty in risk-informed decision making. The NRC discussion described the importance of, and the sources of uncertainty.

The industry, EPRI made their presentation (ADAMS Accession No. ML12229A303). EPRI discussed the codes which were used and the scenarios which were modeled in determining strategies for reducing a radiological release following a severe accident. The outcome of these analysis and assessments discussed for the Mark I and Mark II containments was the decontamination factor for the various scenarios.

At the end of the meeting, the NRC stated that at a future meeting, the NRC would discuss the results of similar analysis that has been performed.
