Dear Mr. Lenois:

This refers to the Independent Spent Fuel Storage Installation (ISFSI) security inspection conducted on June 4-5, 2012, at the Connecticut Yankee Atomic Power Company in East Hampton, Connecticut. The inspection covered the NRC's Additional Security Measures (ASMs) for the Physical Protection of Dry Independent Spent Fuel Storage Installations and was conducted using NRC Inspection Procedure 81311, "Physical Security Requirements for Independent Spent Fuel Storage Installations." The enclosed inspection report documents the inspection results, which were discussed with you on June 5, 2012, and subsequently on July 31, 2012, and are described in the enclosed report.

Based on the results of this inspection, the NRC has determined that one Severity Level IV violation of NRC requirements occurred. This violation is being treated as a Non-Cited Violation (NCV), consistent with Section 2.3.2 of the Enforcement Policy. The NCV is described in the subject inspection report. If you contest the violation or significance of the NCV, provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001, with copies to: (1) the Regional Administrator, Region I; and (2) the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001.
