The purpose of this modification is to revise the contractor key personnel under this contract. Pamela Menefee, Help Desk Specialist (ASC), is replaced with Ofelia Sanchez, and Shawn Gibson, Help Desk Specialist (Church Street), is replaced with Meron Seyoum-Seifu.

Accordingly, Clause C.2, 2052.215-70 Key Personnel, paragraph (a), is revised as follows:

The period of performance from June 1, 2011 through December 31, 2012 remains unchanged.
