Background: UniStar's previous letter (ML12178A451, dated June 21, 2012) had provided a **partial** response to RAI 253 SEB2 4788 question 03.07.02-45. Although this UniStar letter did not classify there response as "partial", the letter did not include the table identifying which sections of the COLA were impacted by the response to this RAI question. The letter stated that UniStar will provide a follow-up letter by July 31, 2012 which will provide the tabulated COLA changes. This UniStar letter was forwarded to SEB2 branch in my email dated June 27, 2012.

Now with that background, please read the following about this current UniStar letter (ML12215A150):

UniStar's letter with ADAMS Accession Number **ML12215A150**, dated July 31, 2012, provides response to Question Number **03.07.02-45** of your **RAI 301 (eRAI 4788)**. The response letter states that this current letter and its Enclosures supersede the previous response provided by their June 21, 2012 letter in its entirety. Therefore, please disregard the previous letter and consider this current letter as UniStar's response to your RAI question. Please also note that the UniStar letter includes a markup of the proposed changes to the applicable sections of the COL application based on the response to this RAI question. A table provided in Enclosure 3 summarizes the list of the specific sections of the COLA that are impacted by this RAI response. Please make sure that you coordinate these changes with the applicable technical branches involved.
