As you may know, Pfizer Inc. ("Pfizer") recently issued a press release regarding the strategic alternatives review process for its Animal Health business, which indicated that preparations are underway to file a registration statement in the U.S. for a potential initial public offering of a minority ownership stake in a new standalone Animal Health company. The standalone company will be named Zoetis™ (pronounced zō-EH-tis). In connection with the foregoing, Pfizer is effecting a reorganization of certain assets related to the Animal Health business. To that end, Pharmacia & Upjohn Company LLC, the current owner of the Kalamazoo Pfizer facilities, will be transferring ownership of the Animal Health facilities to a newly created entity, PAH P&U LLC. Pfizer will continue to be the ultimate corporate parent of this newly created entity.

Thus, we hereby request that NRC byproduct materials license 21-00182-03 be amended to name PAH P&U LLC as the licensee. Notwithstanding this transfer of ownership, we want to assure you that:

- Our operation will proceed as before; and
- We will provide appropriate notice if there is any change in ownership or operation of this facility in the future.

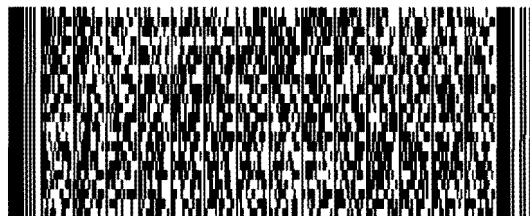

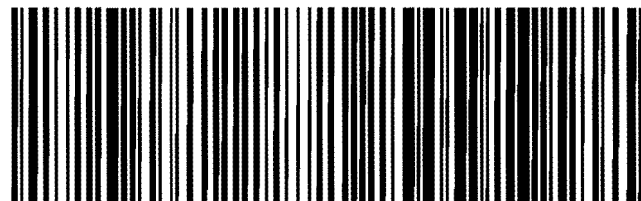
