Pursuant to Nuclear Regulatory Commission regulations in 10 C.F.R. § 30.34(h) (1), Patriot Coal Corporation ("Patriot") hereby provides notice that on July 9, 2012 it filed a voluntary petition for reorganization under Chapter 11 of the Bankruptcy Code in Bankruptcy Court for the Southern District of New York. This filing included substantially all of its wholly owned affiliates and subsidiaries and the cases have been consolidated in Case No. 12-12900. Several of Patriot's affiliated companies with operations in West Virginia are NRC license holders and a complete list of these NRC licenses is provided below..
