During the period July 31 to August 2, 2012, the U.S. Nuclear Regulatory Commission (NRC or the Commission) conducted a security inspection at your Washington State University TRIGA research reactor facility located in the Nuclear Radiation Center. The inspection included a review of activities authorized for your facility. The enclosed report presents the results of that inspection.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations, implementation of certain compensatory measures, and compliance with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel. Based on the results of this inspection, no findings of significance were identified.
