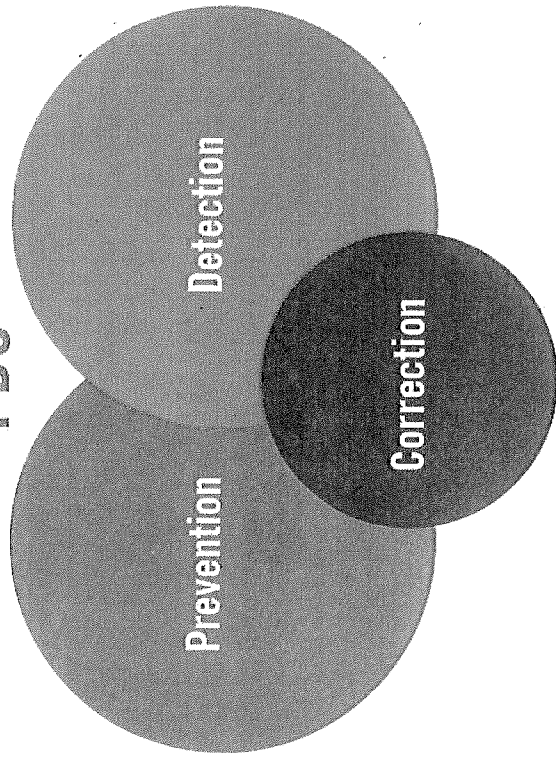


## Nuclear Excellence Model

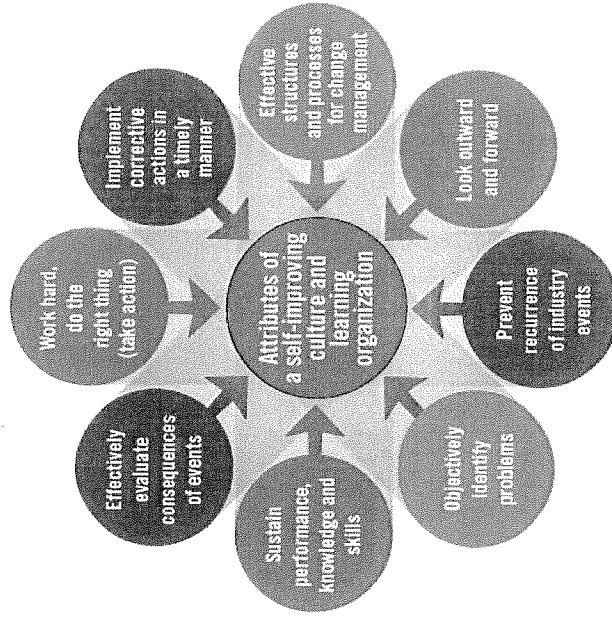
