Purpose: To announce the availability of NUREG-2118 that provides a summary of Agreement State licensee occupational radiation exposure data maintained in the Radiation Exposure Information and Reporting System (REIRS) database between 1997 and 2010.

Background: Annually, NRC licensees report data to the NRC on occupational radiation exposure. This data is maintained in the REIRS database. Agreement States are requested, but not required, to submit occupational radiation exposure data from their licensees to the NRC. Comprehensive analysis of the data in the REIRS database identified trends among Agreement State licensees and allowed comparison of these trends with the data provided by NRC licensees. NUREG-2118 summarizes Agreement State licensee occupational radiation exposure data maintained in the REIRS database from 1997 through 2010 and presents NRC analysis of this data, presented in terms of the collective dose and the dose distribution among the monitored individuals.
