This refers to your letter dated October 31, 2011, requesting renewal of Nuclear Regulatory Commission (NRC) Exempt-Distribution Materials License No. 12-15023-02E, and subsequent letter dated March 30, 2012, requesting that your license be issued pursuant to Code of Federal Regulations, Title 10, Part 32, Section 32.14. We currently do not have sufficient information to complete the review of your amendment request. In order to continue our review we ask that you provide additional information as specified in the attachment to this letter.
