2) Physical Description

This shipment will consist of 1 x 40' flatrack carrying:

- I. 5 x 30B Cylinders, UN2978, Radioactive Material, Uranium Hexafluoride, not fissile or fissile, excepted (Heels)
- II. 13 x 30B Cylinders, UN2977, Radioactive Material, Uranium Hexafluoride, Fissile (Heels)
- III. 2 x 30B Cylinders, UN2908, Radioactive Material, Excepted Packages-Empty Packaging

Total 20 cylinders containing max. 24.121 kgs of Uranium.

3) Transportation and Route Schedule

The ocean transportation from Liverpool, UK to Baltimore, MD will be the responsibility of Atlantic Container Line. The inland transportation from Baltimore, MD to AREVA NP/Richland, WA will be the responsibility of RSB LOGISTIC SERVICES, INC. Entry into the United States will occur at Baltimore, MD on or about May 24, 2012.
