The purpose of the close-out review was to terminate McLinc's NRC Facility Clearance for the possession and use of classified material at the SECRET-Restricted Data level.

During the review, it was verified that all classified documents had been transferred to GLE's facility in Wilmington, North Carolina. A signed "Certificate of Non-Possession" of classified matter was provided to the reviewers. The reviewers also verified that the hard drive to the one standalone computer used for GLE classified work had been removed and taken to the GLE facility in Clinton, Tennessee for destruction. In addition, the reviewers verified that the NRC had terminated all NRC personnel security clearances granted to those McLinc employees who were working on the GLE project. Based on the results of this review, the NRC Facility Clearance for the GLE McLinc facility is hereby terminated.
