## 3) Transportation and Route Schedule

Sea freight on the Atlantic Conveyor V. 2270. Vessel sails Liverpool, UK on May 26, 2012. Due to the Port of Halifax, NS on June 3, 2012 and will unload. RSB will then pick up and cross the Canada/USA border at Lacolle, PQ/Champlain, NY or Woodstock, NB/Houlton, ME on/about June 8, 2012.
