This letter supersedes the request for additional information (RAI) 329, Question 01-14 schedule letter transmitted on July 19, 2012 (Reference 3). The Reference 3 letter was signed and transmitted on July 19, 2012, but was incorrectly dated June 19, 2012, on the first page of the cover letter.

The purpose of this letter is to respond to the RAI identified in the NRC e-mail correspondence to UniStar Nuclear Energy, dated December 14, 2011 (Reference 1). The RAI requests that applicable sections of the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3 Combined License Application (COLA) be identified which provide information specific to 10 CFR Parts 30, 40 and 70 requirements.


Reference 2 indicated that a response to RAI 329 would be provided to the NRC by July 20, 2012. UniStar Nuclear Energy requires additional time to coordinate the CCNPP Unit 3 response with the PPL Bell Bend, LLC (PPL) response on the equivalent PPL RAI. The response to RAI 329 will be provided by August 24, 2012.

There are no regulatory commitments identified in this letter. This letter does not contain any sensitive or proprietary information.
