On August 3, 2012, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Nine Mile Point Nuclear Station. The inspection covered one of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed on August 3, 2012, with Mr. G. Stefe, General Supervisor, Fix-It Now (FIN) Team, and other members of your staff.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

Based on the results of this inspection, no findings were identified.
