In light of the suspension of the Executive Order of February 25, 2011, "Blocking Property and Prohibiting Certain Transactions Related to Libya", the United States Nuclear Regulatory Commission (NRC) hereby rescinds the Order Suspending Licenses for exports to Libya dated August 2, 2012. The licenses affected by the Order included NRC specific license PCB103.01 and general licenses authorizing exports of source, special nuclear or byproduct materials in accordance with 10 C.F.R. Part 110.
