## CLOSURE OF BULLETIN 2011-01, "MITIGATING STRATEGIES"

**Description:** In light of the events at Fukushima Dai-ichi Nuclear Power Station following the March 11, 2011, earthquake and tsunami, the U.S. Nuclear Regulatory Commission (NRC) issued Bulletin 2011-01, "Mitigating Strategies," in order to comprehensively verify licensee compliance with Title 10 of the *Code of Federal Regulations* (10 CFR) Section 50.54(hh)(2) and to obtain information associated with licensee mitigating strategies.

**Background:** The events in Japan highlighted the importance and potential versatility of B.5.b mitigating strategies. Therefore, the NRC sought comprehensive confirmation that licensees maintain equipment and strategies to satisfy 10 CFR 50.54(hh)(2).

Bulletin 2011-01 requested responses to two sets of questions pursuant to the provisions of 10 CFR 50.54(f). The purpose of the first set of questions was to confirm compliance with 10 CFR 50.54(hh)(2). The purpose of the second set of questions was to obtain information on licensee programs to maintain compliance with 10 CFR 50.54(hh)(2).

**Outcome:** The NRC documented the outcome of its review of responses to the bulletin in a memorandum dated July 20, 2012 (ADAMS Accession No. ML121910389). As stated in the memorandum, NRC staff reviewed all the licensee responses to Bulletin 2011-01 and found that each licensee provided the information requested. Each licensee was sent a letter documenting this finding with a summary of the staff's review.

The NRC staff did not identify any noncompliances or any items that would need follow-up by inspectors as a result of its review. The NRC staff notes that all licensees identified actions taken since the March 11, 2011, event at Fukushima Dai-ichi to ensure that the 10 CFR 50.54(hh)(2) mitigation strategies remain feasible. Insights gained from the bulletin responses have been used to inform other post-Fukushima activities, such as the recently issued interim staff guidance (ADAMS Accession No. ML12229A174) for Order EA-12-049.

**Current Status:** The original action plan was initiated on July 11, 2011 (ADAMS Accession No. ML111881015). All actions in the action plan are complete.
