 "G.3 2052.216-71 Indirect Cost Rates (Jan 1993)

(a) The contractor and NRC have mutually agreed on the final indirect rates for Fiscal years 2007 through 2010. Fiscal Year 2011 and FY 2012 shall be reimburse for allowable indirect costs based on the provisional rates currently stated in the contract as follows:
