

The following changes are hereby incorporated into Task Order No: NRC-DR-09-09-328:

1. In accordance with Clause A.18 – 52.217-9 Option to Extend the Term of the Contract (MAR 2000) Option Period Three is hereby exercised. The period of performance for Option Period Two is October 1, 2012 through November 11, 2013.
2. Clause A.2 – Consideration and Obligation – delete the current version in its entirety and replace with the following:
 - a) The total estimated ceiling for this order is \$8,420,072.04 as follows:
 - 1) The total estimated ceiling for CLINs 1 – 16 is \$5,232,670.04
 - 2) The total estimated ceiling for CLINs 17 – 28 is \$3,187,402.00
 - b) The amount presently obligated for CLINs 1 – 16 is \$3,453,648.00. CLINs 17 – 28 will be paid via a centrally billed account in accordance with the GSA ETS ordering guide. The funds for these CLINs will not be obligated under this contract.”
3. Incremental funding in the amount of \$500,000.00 is hereby added to the order increasing the order obligation by \$500,000.00 from \$2,953,648.00 to \$3,453,648.00.
4. As a result of the exercise of Option Period Three the order ceiling is hereby increased by \$2,175,778.80 from \$6,244,293.24 to \$8,420,072.04.
5. All other terms and conditions of Task Order No: NRC-DR-09-09-328 hereby remain unchanged and in full force and effect.
