STATUS REPORT

In accordance with the Atomic Safety and Licensing Board's (Board) Initial Scheduling Order,¹ the NRC staff (Staff) is providing the Board with the Staff's Status Report. On August 28, 2012, the applicant, Exelon Generation, notified the Staff that it was withdrawing its Early Site Permit application for the Victoria County Station site.² On August 29, 2012, the applicant filed an unopposed Motion to withdraw its application without prejudice.³ In light of the applicant's request to withdraw the ESP application, the Staff has discontinued its technical review.
