

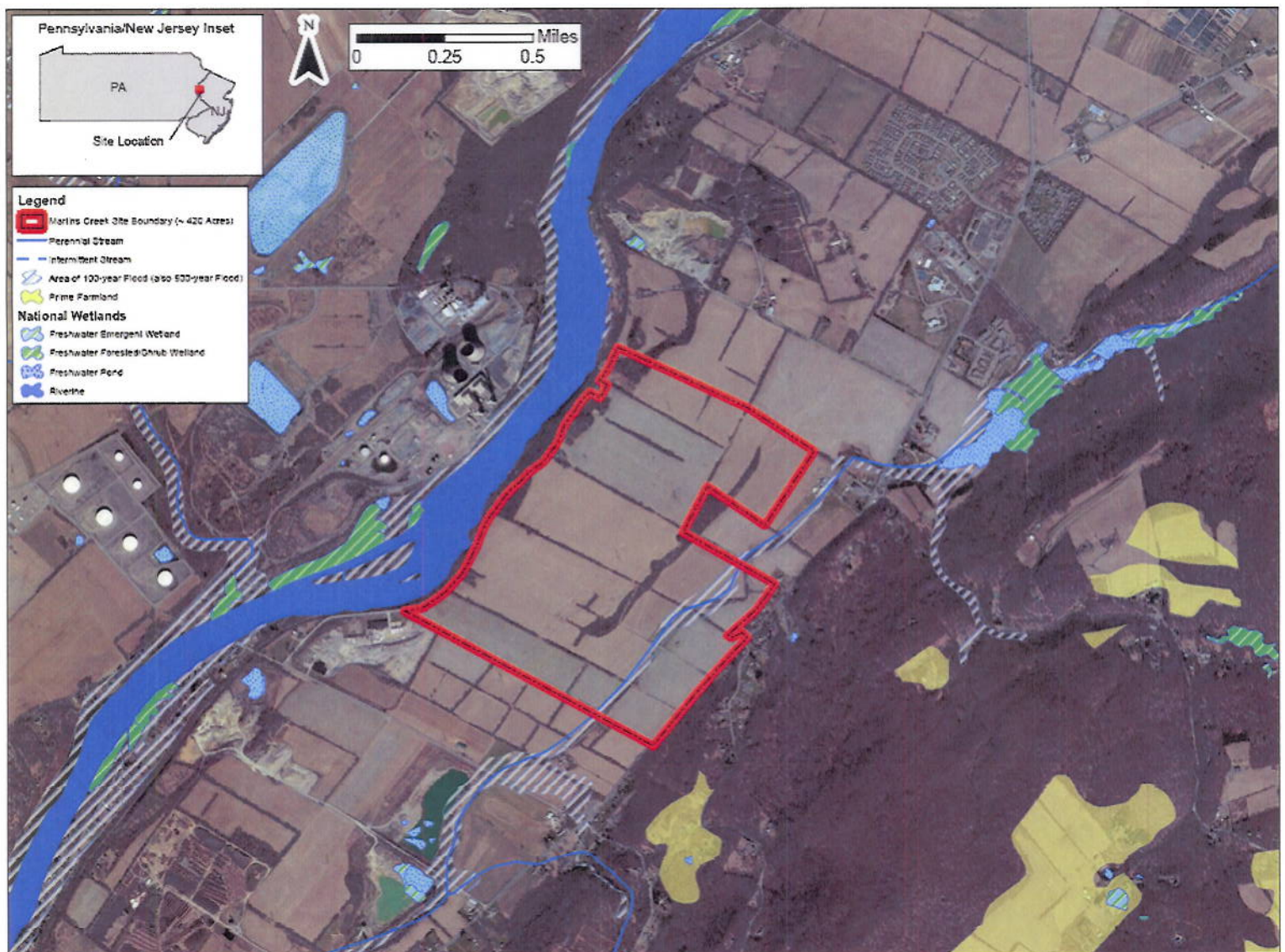

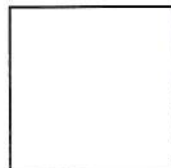
Dear Mr. Sterbenz,

Can you please tell me how I can find the Block and Lot Numbers for the area outlined in red on the attached map (which I found on this website: http://www.highlands.state.nj.us/njhighlands/master/rmp/final/atlas/atlas_grid_grid1.pdf) ? (The property is in the SW corner of White Twp. It adjoins Rt. 519 and S. Foul Rift Rd.) --I'm asking because this area has been proposed as an "Alternative Site" for us to analyze in an environmental impact statement for the proposed Bell Bend (near Berwick, PA) nuclear power plant. The applicant (PPL) does not want to actually apply for a construction permit, but we need to know if it would it even be possible to get one.
