Mr. McNeil,

In support of your request to authorize Geoffrey L. Day as the Radiation Safety Officer, please provide the following:

- a. Description of the training and experience specified in 10 CFR 35.50(e) demonstrating that the proposed RSO is qualified by training in radiation safety, regulatory issues, and emergency procedures applicable to the types of use for which the applicant seeks approval of an individual to serve as RSO;
- b. Written attestation, signed by a preceptor RSO, that the individual satisfactorily completed the requirements in 35.50(c)(2), as well as the required training and experience in radiation safety,

regulatory issues, and emergency procedures for the types of use for which the licensee seeks approval and has achieved a level of radiation safety knowledge sufficient to function independently as an RSO.
