

The purpose of this Task Order modification is to provide incremental funding in the amount of \$8,000.00 thereby increasing the obligated amount from \$805,298.00 to \$813,298.00. Accordingly, Page Two (2), Paragraph Three (3) of Task Order 51 is revised to the following:
"The amount presently obligated by the Government with respect to this Task Order is \$813,298.00, of which \$769,076.00 represents the reimbursable costs, and the amount of \$44,222.00 represents the fixed fee".
