Dear Ms. Smith:

By letter dated August 30, 2012 (Agencywide Documents Access and Management System Accession No. ML12244A442), CS Innovations submitted an affidavit executed by Scott Roberts, President, CS Innovations dated August 30, 2012, requesting that the information contained in the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

1. Document titled "6002-00003, ALS V&V Plan," Rev. 7
2. Document titled "6002-00005, ALS Test Plan," Rev. 3
3. Document titled "6002-00010, ALS Platform Requirements Specification," Rev. 14
4. Document titled "6002-00011, ALS Platform Specification," Rev. 10
5. Document titled "6002-00018, ALS Platform FPGA V&V Test Plan," Rev. 4

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

(i) The information sought to be withheld from public disclosure is owned and has been held in confidence by Westinghouse.

(ii) The information is of a type customarily held in confidence by Westinghouse and not customarily disclosed to the public. Westinghouse has a rational basis for determining the types of information customarily held in confidence by it and, in that connection, utilizes a system to determine when and whether to hold certain types of information in confidence. The application of that system and the substance of that system constitutes Westinghouse policy and provides the rational basis required.

(iii) The information transmitted to the NRC was done so in confidence and, under the provisions of 10 CFR Section 2.390, it is to be handled in confidence by the Commission.

(iv) The information sought to be protected is not available in public sources or available information has not been previously employed in the same original manner or method to the best of our knowledge and belief.
