Last time we spoke, we discussed the evacuation plan for Sing-Sing as part of the Indian Point Energy Center License renewal. as we discussed, I listed your name as point of contact for the evacuation plan. I was requested by my Office of General Counsel to see if it would be at all possible for me to look at the plans. I would travel to wherever to meet whomever, would look at the plans... i would take no notes, no recordings, nothing... I have an "L" clearance and am in the process of an upgrade to a "Q" clearance. so the USG trusts me with secrets. Any questions I would be asked would be answered with "Yes I have seen the plans and they provide for adequate protection for the prison population however, the plans are safeguards or secret (what ever is the designation) and I am not at liberty to discuss them. We remain confident in the abilities of the NYSDOC to care for its prison population in an emergency situation"

without actually seeing the plans, our statements are very very weak.
