SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR MILLSTONE POWER STATION, UNIT NO. 3 (TAC NO. ME8455)

Dear Mr. Heacock:

By letter dated April 12, 2012, Dominion Nuclear Connecticut, Inc. (DNC) submitted the affidavit executed by Mr. J. A. Gresham, Manager, Regulatory Compliance, Westinghouse Electric Company, dated March 21, 2012.

The affidavit requested that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

Attachment 3 to the letter from Dominion Nuclear Connecticut, Inc., (Mr. J. Alan Price, Site Vice President-Nuclear Engineering), Serial No: 12-203, dated April 12, 2012, "Westinghouse Electric Company LLC, LTR-SGMMP-11-28 Rev. 1 P- Attachment, "Response to USNRC Request for Additional Information Regarding the License Amendment Requests for Permanent Application of the Alternate Repair Criterion, H*, to the Model D5 and Model F SGs," February 2, 2012, (Proprietary)."

The affidavit from Mr. Gresham of Westinghouse Electric Company LLC stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)(ii)(a). The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
- (4)(ii)(c). Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.


