Dear Mrs. Forster:

In the letter sent to you on July 18<sup>th</sup>, 2012 we informed you about the intent of Community Hospital Anderson, 1515 N Madison Avenue, Anderson, Indiana, to purchase Madison County Cancer Care Center, 1340 N Madison Avenue, Anderson, Indiana.

Per NUREG 1556 Volume 9, Appendix G – Transfer of Control, I will summarize the necessary information needed for the transfer of control that will take place on August 27, 2012.

The transfer of control will be a direct acquisition and the new name of the facility will be Community Hospital Anderson Radiation Oncology Department. The contact person of the transferee will be Mr. John Harris; phone: 765-298-5286, and for Madison County Cancer Care Center will be Dr. Currier, phone 765-622-7600.

There will be no changes in personnel or duties that relate to the licensed program. James Currier, M.D., R.S.O will continue to provide treatment and will continue his duties as Radiation Safety Officer. Dr. Currier and all the Authorized Users that are on current license will continue to fulfill their responsibilities. Ana Mihail, physicist, and all the Medical Authorized Physicists currently on the license will continue to fulfill their responsibilities as well.

There will be no changes in the organization, location, facility and equipment and procedures that are currently provided.

There will be no change in the status of the surveillance program: including surveys, wipe tests, and quality control.

All records and documents concerning the safe operation of the facility and all patient records will be transferred to the transferee.

I am asking for your approval for the transfer of ownership and the license to operate.
