SUBJECT: REQUEST FOR WITHDRAWAL OF EARLY SITE PERMIT APPLICATION FOR
VICTORIA COUNTY STATION SITE

Dear Ms. Kray:

By letter dated March 25, 2010, Exelon tendered an Early Site Permit (ESP) application for the Victoria County Station (VCS) site located in Victoria County, Texas to the Nuclear Regulatory Commission (NRC). The ESP application for VCS was accepted for docketing on June 8, 2010. By letter dated August 28, 2012, Exelon Nuclear Texas Holdings, LLC (Exelon) requested that the ESP application for the VCS site be withdrawn from the docket. The purpose of this letter is to inform you that we have received your request to withdraw the ESP application for VCS site.

In accordance with the requirements of 10 CFR 2.107(a), and on the basis of the statements contained therein, your request to withdraw the VCS ESP application from the docket has been accepted. Enclosed in this letter is a copy of the *Federal Register* Notice announcing the withdrawal of the application from the docket, as required by 10 CFR 2.107(c). In addition, on September 6, 2012, NRC staff held a teleconference with Mr. David Distell to discuss closure plans for the application. During that call, the NRC indicated that although all technical reviews stopped on August 28, 2012, the NRC gave Exelon a preliminary estimate of the additional work that is necessary for the NRC to administratively close out the application. Mr. Distell acknowledged that the estimate for these activities was reasonable and any resulting new charges were understandable based on the discussions.
