SUBJECT: SUMMARY OF AUGUST 30, 2012, PUBLIC MEETING
REGARDING SEISMIC REEVALUATION GUIDANCE
DOCUMENT DEVELOPMENT

On August 30, 2012, the U.S. Nuclear Regulatory Commission (NRC) staff held a public meeting¹ with the Nuclear Energy Institute and industry representatives, including the Electric Power Research Institute, to discuss *Near-Term Task Force (NTTF) Recommendations for Enhancing Reactor Safety in the 21st Century* report, issued July 12, 2011². The meeting focused specifically on NTTF Recommendation 2.1, seismic reevaluation, which has been identified by the NTTF as a Tier 1 recommendation. Tier 1 recommendations are those under consideration for implementation without unnecessary delay. During this meeting, the participants continued their development of the guidance document on screening, prioritization and implementation details, as they relate to the seismic reevaluation recommendation.

The meeting participants used a webinar format to review and edit the draft guidance document. Following the meeting, the resulting draft, including comments, was made publically available in the NRC Agencywide Documents Access and Management System under Accession No. ML12248A023.
