Dear Mr. Gregg:

This letter acknowledges receipt of the Aptuit (licensee) resubmitted Decommissioning Plan dated August 30, 2012 (ML12248A095) pursuant to 10 CFR 30.36(d). An acceptance review of the Decommissioning Plan will be performed by the U.S. Nuclear Regulatory Commission (NRC) within 90 days. After the acceptance review is complete, the NRC may initiate a comprehensive technical review of the licensee's Decommissioning Plan. The results of NRC's review will be communicated to the licensee when the review is complete.

In the letter dated August 30, 2012, the licensee had requested an expedited review of the Decommissioning Plan. Please provide justification for your requested expedited review and approximate date when the approval is requested.
