The purpose of this modification is to close this task because all of the work has been completed and deobligated funds in the amount of \$8,528.60. Therefore, the obligation amount is decreased by \$8,528.60 from \$34,785.30 to \$26,256.70. Accordingly the first sentence of paragraph (b) of the consideration and obligation clause is revised to read as follows "(b) The amount obligated with respect to the government is \$26,256.70."
