SYNOPSIS

This investigation was initiated by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI), Region II (RII), on December 14, 2011, to determine whether a Health Physics (HP) Technician, at the Turkey Point Nuclear Plant (Turkey Point) was discriminated against for raising safety concerns.

Based upon the evidence developed during this investigation, OI:RII did not substantiate that a Health Physics (HP) Technician was discriminated against for having raised safety concerns.
