Dear Deputy Secretaries and Chiefs of Staff:

This note is to remind you of your responsibilities under OMB <u>Memorandum 11-35</u>, "Eliminating Excess Conference Spending and Promoting Efficiency in Government." This memorandum instructed all agency Deputy Secretaries "to conduct a thorough review of the policies and controls associated with conference-related activities and expenses." In conducting such reviews and certifying that the appropriate policies and controls are in place, agencies must ensure compliance with both the <u>Federal Travel Regulation</u> (FTR), which implements statutory directives and executive branch policies related to travel and conferences, and the <u>Federal Acquisition Regulation</u> (FAR), which governs Federal contracting for goods or services to support travel and conference activities, including contracts for facilities and for training services.
