Level 2 Probabilistic Risk Analysis (PRA) Logic Model Development and Thermal-Hydraulic Modeling and Analysis Support for the Full Scope Site Level 3 PRA Project

On September 6, 2012, as a result of a competitive negotiated acquisition, a cost reimbursement, fixed-fee Indefinite Quantity-Indefinite Delivery contract (NRC-HQ-12-C-04-0087) was awarded to Energy Research, Inc. of Rockville, MD. The contractor will support the development of the Level 2 PRA Logic Model and the Thermal-Hydraulic aspects of the Full-Scope Level 3 PRA project. The period of performance is September 6, 2012, to September 5, 2016. The estimated value of this four-year contract is \$553,091.04.

Fitness-for-Duty Programs: Regulatory basis and preliminary proposed rule language; 10 CFR Part 26 (NRC-2009-0090)

On September 10, 2012, the NRC published a document in the *Federal Register* (77 FR 55429) announcing the availability of two rulemaking documents related to the ongoing proposed rulemaking effort to amend its regulations regarding Fitness-for-Duty Programs. The released documents include the regulatory basis and preliminary proposed rule language for requiring personnel performing certain quality control and quality verification duties to comply with the work hour provisions. The availability of these documents allows interested stakeholders to prepare for future public meetings. The NRC is not soliciting formal public comments on these documents at this time. Additional documents related to this proposed rulemaking will periodically be made publicly available.

Seismic Hazard Review for the Western United States Nuclear Power Plants and Development of Flood Hazard Integrated Assessment Staff Guidance Applicable to United States Nuclear Power Plants

On September 10, 2012, as a result of a noncompetitive acquisition, a cost-plus-fixed-fee type contract (NRC-HQ-12-C-42-0083) was awarded to Southwest Research Institute of San Antonio, TX for technical assistance in support of seismic hazard reviews for the Western United States Nuclear power plants and development of flood hazard integrated assessment staff guidance applicable to United States Nuclear Power Plants. The period of performance is September 10, 2012, to September 28, 2013, with two one-year option periods. The total estimated cost is \$773,791, inclusive of options.
